### 5.1 Follow up - Sunset Community Foundation

They noted that there could be a Committee set up under the Foundation to review applications and provide recommendations to the Foundation Board. The agreement would be set up with specific terms, which could include a boundary area (ie. geographic boundary for applicants/funds to be used).
